“PSW for Psychologists: New Hires and PSW Novices-Dehn’s Processing Strengths and Weaknesses Model”

Prerequisite:

Participants will be required to complete *Dehn’s PSW Model for Beginners*, a free self-paced online course, prior to attending this workshop. Once registered, a link will be provided. The course will take approximately 3 hours. Please ensure that you schedule adequate time to complete the prerequisite course prior to the first training date.

Please download the PSW Manual from the VC SELPA website prior to the training. You don’t need to print it out; just please have it available on your device so that you may access it during the training.

Workshop Description:

This will be a 1.5-day workshop. The first day will take psychologists through the 10 steps of the Ventura County PSW Assessment Model with an emphasis on incorporating the use of Dehn’s Processing Strengths and Weaknesses Model throughout a psychoeducational assessment for SLD. The most recent version of the corresponding software will be reviewed, and training will be provided on integrating assessment results into a comprehensive psychoeducational assessment report.

The half day follow up training will take place 3 months later once psychologists have had the opportunity to use the PSW model on real cases at their school sites. Presenters will run through more complex case studies and allow participants to work through each using software, problem solving skills and clinical judgment.

For districts utilizing Dehn’s approach, access to the *Essential of Processing Assessment- Second Edition* and the Psychological Processing Analyzer (PPA) software are recommended. Participants are strongly encouraged to bring a laptop with updated PPA software to participate in the hands-on case study activity.
